COPY OF REGISTRATION PAPERS MUST BE INCLUDED WITH THIS CONTRACT.

1. **VETERINARIAN CERTIFICATE PRIOR TO MARE ARRIVAL:** Mare owner shall furnish to La Dulce Vida Arabians at or before delivery of mare a Veterinary Information Sheet provided by La Dulce Vida Arabians indicating that said mare is suitable for breeding and free of infectious, contagious or transmissible disease, and has normal reproductive organs. A negative coggins test is required – taken within 12 months prior to delivery. Current inoculations are also required.
2. **METHOD OF BREEDING:** The method of breeding shall be at the sole discretion of La Dulce Vida Arabians so long as the method used is approved by the Arabian Horse Association.
3. **RELEASE OF LIABILITY:** Neither La Dulce Vida Arabians or Charles Suarez or Martha Suarez, nor any of their agents or employees is to be held liable or responsible in any way whatsoever for any sickness, disease, estray, theft, death or injury to or incurred by said mare while at La Dulce Vida Arabians.
4. **CARE OF MARE:** La Dulce Vida Arabians shall have complete discretion as to all veterinary and blacksmith care and the feeding program of the mare while at La Dulce Vida Arabians.
5. **BOARDING RATE:** Refer to current Fee Schedule.
6. **BREEDING FEE:** Stud Service Fee: \$_____. Twenty Percent (20%) due at time of booking \$_____.
The booking fee is nonrefundable, payable upon execution of this contract. The balance is: \$_____ and due when the mare leaves the farm.
7. **ADDITIONAL CHARGES:** All Veterinary and Blacksmith expenses.
8. None of the above mentioned fees shall be refundable. This breeding cannot be resold or transferred. However, La Dulce Vida Arabians guarantees a return breeding the following season either for said mare or an approved substitute shall a live foal (defined as one that stands and nurses without assistance) not result from this mating. A written report from a licensed equine practitioner within one week of the death is required.

If the mare is to be rebred and the mare owner fails to deliver her for breeding the following year, then any and all fees paid shall not be refundable and this Agreement shall be thereby cancelled.

If the stallion shall be no longer leased or owned or standing at La Dulce Vida Arabians or otherwise unable to or unavailable for breeding, the mare may be bred to another stallion owned or leased by La Dulce Vida Arabians.

9. **SERVICE BY ANOTHER STALLION:** Service of mare by another stallion after her departure from La Dulce Vida Arabians automatically voids this contract and La Dulce Vida Arabians reserves the right to refuse to execute any papers necessary for the registration of any foal from said mare.
